

ORDINANCE NO. 624

**AN ORDINANCE OF THE CITY OF WILSONVILLE AMENDING
CHAPTER 5: VEHICLES AND TRAFFIC CODE, REPEALING W.C. 5.505
CONCERNING AND RELATING TO SLEDS ON STREETS.**

WHEREAS, W.C. Chapter 5 Vehicles and Traffic Code regulates parking, traffic and impoundment of vehicles on the streets and property of the City of Wilsonville;

WHEREAS, W.C. 5.505 prohibits the use of streets for traveling on skis, toboggans, sleds or similar devices.

WHEREAS, City Council prefers to allow use of streets for snow-dependent devices such as skis and sleds, so long as their use is regulated in a safe manner.

WHEREAS, instead of a prohibition on use of streets for snow-dependent devices, City Council prefers the regulation of snow-dependent devices on the streets in the same manner that Pedestrians are regulated, as prescribed under State and local laws.

WHEREAS, the regulation of snow-dependent devices under the same laws as Pedestrians requires the incorporation of a new and broad definition of Pedestrians and a repeal of the prohibition on the use of the streets for snow-dependent devices.

NOW THEREFORE, THE CITY OF WILSONVILLE ORDAINS AS
FOLLOWS:


Section 1. Wilsonville Code Section 5.035 Definitions is amended to add subsection (k) as follows:

“Pedestrian. A person afoot; a person operating a pushcart; a person riding on or pulling a coaster wagon, sled, scooter, tricycle, bicycle with wheels less than 14 inches in diameter, or a similar non-motorized vehicle; or on roller skates, skateboard, skis, snowboard, wheelchair, or a baby in a carriage.”

Section 2. Wilsonville Code Section 5.505 Sleds On Streets is repealed.

~~“Sleds on Streets. No person shall use the streets for traveling on skis, toboggans, sleds or similar devices, except where authorized.”~~
