ORDINANCE NO. 227

AN ORDINANCE AMENDING SECTION 2.105(2)(d) OF THE WILSONVILLE CODE.

WHEREAS, Section 2.105(2)(d) of the Wilsonville Code currently provides that the city administrator shall have authority to make expenditures not to exceed \$1,000.00 in any one transaction without formal bid procedures; and

WHEREAS, the City Charter, Chapter XI, Section 4, sets \$2,000.00 as the minimum before public bids are required on public improvements and Section 2.314 of the City Code requires a bid for contracts in excess of \$2,000.00; and

WHEREFORE, there is a potential conflict between the latter two provisions and Section 2.105(2)(d) of the Wilsonville Code;


NOW, THEREFORE, the City of Wilsonville Ordains as follows:

1. Section 2.105(2)(d) of the Wilsonville Code is amended to delete the words "without formal bid procedures" from the end of that subsection, so that it reads as follows:


"(d) Be the chief purchasing and business agent with respect to all departments of the city and, within budgetary limits and purposes, shall have authority to make expenditures not to exceed One Thousand and no/100 (\$1,000.00) Dollars in any one transaction;"
