

**RESOLUTION NO. 1525**

**A RESOLUTION ADOPTING THE CANVASS OF VOTES OF THE  
NOVEMBER 3, 1998 GENERAL ELECTION.**

WHEREAS, at the General Election held November 3, 1998, the electorate of the City of Wilsonville cast ballots for three City Councilor positions; and

WHEREAS, two of the City Council positions are four-year terms, and one City Council position is a two-year term; and

WHEREAS, the election of the registered voters of Clackamas County was conducted at the polls; and

WHEREAS, the County Clerk of Clackamas County, who by statute, is in charge of conducting all elections, has filed an abstract of the tally of votes cast at the election, which tally for Clackamas County was received on November 23, 1998, and for Washington County was received on November 30, 1998.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:


