A RESOLUTION ADOPTING THE CANVASS OF VOTES OF THE **NOVEMBER 7, 2000 GENERAL ELECTION.**

WHEREAS, at the General Election held November 7, 2000, the electorate of the City of Wilsonville cast ballots for Mayor and two City Councilor positions; and


