RESOLUTION NO. 1993

A RESOLUTION OF THE CITY OF WILSONVILLE AUTHORIZING ACQUISITION OF PROPERTY INTEREST IN ORDER TO CONSTRUCT A WEST SIDE NEIGHBORHOOD PARK TO SERVE THE MONTEBELLO AREA

WHEREAS, under and by virtue of the laws of the State of Oregon the City of Wilsonville is duly authorized and empowered to acquire such real property as may be deemed necessary and proper for identified public improvements; and

WHEREAS, Section 3.1 – "System Overview" of the Draft Parks and Recreation Master Plan recommends that the ideal park system for Wilsonville "is one made up of a hierarchy of various park types" and that the "basic concept of the recommended system is to assure that every neighborhood in Wilsonville is served by either a neighborhood park or community park"; and

WHEREAS, the existing Montebello Park is a small beautification area that is not suitable to meet the recreation needs of the surrounding neighborhood; and

WHEREAS, to provide access to basic recreation opportunities and to enhance neighborhood identity, a new neighborhood park is needed; and

WHEREAS, Section 3.2 – "Park System Improvements" of the Draft Parks and Recreation Master Plan identifies site P8, referred to in Exhibit 1, attached hereto and incorporated herein by this reference, as a "proposed neighborhood park to serve the currently underserved Montebello area."; and

WHEREAS, the Draft Parks and Recreation Master Plan calls for acquisition of a suitable site that meets the City's design and development guidelines for neighborhood parks and recommends a site approximately one acre in size; and

WHEREAS, tax lot 31W14C 01300 owned by the Harry V. Hodges Living Trust, Friedgard V. Van Eck, Trustee is a .68 acre site immediately adjacent to the existing Montebello Park meets the recommendations set forth in the Draft Parks and Recreation Master Plan for a new neighborhood park to serve the Montebello area; and

WHEREAS, the City of Wilsonville is authorized to acquire property by legal means, including eminent domain, for a public purpose; and

WHEREAS, the procedures for property acquisition requiring eminent domain shall conform to all statutory requirements to ensure that property owners' rights are fully respected.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

- 1. There is needed and required, for the public purpose of providing a neighborhood park to serve the Montebello area of Wilsonville, acquisition of property interest of that property identified in Exhibit 2, attached hereto and incorporated herein by this reference.
- 2. The property interest is required as a result of the aforementioned public improvement, and the improvement has been planned and located in a manner most compatible with the greatest public good and the least private injury and in accordance with the recommendations set forth in the Draft Parks and Recreation Master Plan.
- 3. City of Wilsonville staff and attorneys are authorized and directed to negotiate with the owners of the real property herein described as to the compensation to be paid for the acquisition of the property and, in the event agreement cannot be reached, then to commence and prosecute to final determination such condemnation proceedings as may be necessary to acquire the real property or property interest.
- 4. Upon trial of an action of condemnation, the attorneys for the City are authorized to make such stipulation, agreement or admission as in their judgment may be in the best interests of the City.
- 5. The City of Wilsonville anticipates it will acquire the above-described property in the spring of 2006.
 - 6. This resolution is effective upon adoption.





LEGAL DESCRIPTION

Acquisition of Property for a New Neighborhood Park to Serve the

Montebello Area

Summary: The City of Wilsonville's Draft Parks and Recreation Master Plan identifies the need for a new neighborhood park to serve the Montebello area. A property immediately adjacent to the existing Montebello Park, owned by the Harry V. Hodges Living Trust, Friedgard V. Van Eck, Trustee, is appropriately sized and located to meet this need. The acquisition of a land for a new neighborhood park in the Montebello area is necessary to better serve this neighborhood and to carry out the objectives set forth in the Draft Parks and Recreation Master Plan.

Recommendation: Staff recommends the Council adopt a resolution authorizing acquisition of the above-mentioned property for the development of a new neighborhood park in the Montebello area.
