A RESOLUTION OF THE CITY OF WILSONVILLE APPROVING THE TOLLING OF DAN REEVES' BALLOT MEASURE 37 CLAIM M37-002-006 UNTIL JUNE 18, 2007.

WHEREAS, Dan Reeves, has filed an ORS 197.352 (Ballot Measure 37) claim for loss of value of certain property owned in the City due to restrictive land use regulations since acquisition of the property, a copy of the claim is on file with the City Recorder; and

WHEREAS, the City is prepared to proceed with the public hearing as scheduled on April 16, 2007, (attached is the preliminary staff report);

WHEREAS, Dan Reeves has requested through his attorney William T. Buckley, by letter of April 11, 2007; a postponement of the public hearing; and

WHEREAS, the claimant has agreed to toll the City of Wilsonville's 180 day limit under ORS 197.352 for an additional sixty-six (66) days; and

WHEREAS, staff recommends that the set over/tolling request be accommodated.

NOW, THEREFORE, THE CITY LF WILSONVILLE RESOLVES AS FOLLOWS:

- 1. The above recitals are incorporated by reference as findings as if fully set forth herein;
- 2. At the request of the claimant the hearing shall be postponed until the June 18, 2007 City Council meeting;
- 3. The tolling agreement is a compromise of a disputed claim agreed upon by the parties with conditions and is not a land use regulation;
 - 4. This resolution shall take affect upon adoption.
