

RESOLUTION NO. XL

A RESOLUTION AUTHORIZING EXECUTION OF CONTRACT FOR THE CONSTRUCTION OF THE BROWN ROAD LATERAL SEWER AND PARKWAY PUMP STATION.

WHEREAS, the City Council has employed Cornell, Howland, Hayes and Merryfield, Consulting Engineers of Portland, Oregon, to prepare plans and specifications and provide engineering services during the construction of the Brown Road Lateral Sewer and the Parkway Pump Station; and

WHEREAS, the City has called and received bids and said bids were received and publicly opened on August 22, 1972, and the lowest, which was also an acceptable bid, was that of Marshall Associated Contractors, Incorporated of Portland, Oregon, with a total bid price of \$27,708.25; and

WHEREAS, the City has agreed to construct the Brown Road Lateral Sewer for Mr. Henry C. Adovnik, an individual of Wilsonville, under the provisions of Ordinance No. 25, which provides for refunding of cost; and

WHEREAS, the applicant has approved the award and has agreed to deposit the amount of \$20,208.25 in the City's Special Fund for Extensions of Utility Lines (Ordinance No. 25) to cover the estimated construction cost of the Brown Road Lateral, and it being understood that applicant will make up any deficiency and the City will refund any surpluses at the time final construction cost is known; and

WHEREAS, the oversizing cost for the 410 feet of a 10-inch sewer approved by the City is \$225.50, which will be deducted from the final sewer cost to Mr. Adovnik and charged against the Sewer Fund; and

WHEREAS, the cost of advertising and reproduction of the plans and specifications will be shared equally by the City and Mr. Adovnik and that the Engineer will determine the amount and manner in which compensation will be made; and

WHEREAS, the successful bidder is ready, willing and able to proceed with the construction contract in accordance with the plans, specifications and proposal for the said project, and it is necessary that a formal written Contract be approved and executed by and between Marshall Associated Contractors, Inc. and the City of Wilsonville; now, therefore,

BE IT RESOLVED by the Common Council for the City of Wilsonville, Clackamas and Washington Counties, Oregon, that the bid proposal of Marshall Associated Contractors, Inc. of Portland, Oregon, for the construction of the Brown Road Lateral Sewer and the Parkway Pump Station in the amount of \$27,208.25 is hereby approved and accepted, and the Mayor and City Recorder are hereby authorized and directed to make, execute and deliver the Construction Contract for said project with Marshall Associated Contractors, Inc. upon receipt from Henry C. Adovnik of the estimated construction costs, and the contract amount shall be paid to the contractor from the said Special Fund upon receipt of billings approved by the City's Engineer and the City Council. The City's Engineer is hereby authorized to provide the necessary surveying, inspection and services during construction as specified in the engineering agreement dated August 15, 1972.

WHEREAS, the successful bidder is ready, willing and able to proceed with the construction contract in accordance with the plans, specifications and proposal for the said project, and it is necessary that a formal written Contract be approved and executed by and between Marshall Associated Contractors, Inc. and the City of Wilsonville; now, therefore,

Adovnik of the estimated construction costs, and the contract amount shall be paid to the contractor from the said Special Fund upon receipt of billings approved by the City's Engineer and the City Council. The City's Engineer is hereby authorized to provide the necessary surveying, inspection and services during construction as specified in the engineering agreement dated August 15, 1972.
