SUBJECT: Purchase of Chlorine


In accord with your request I have reviewed the documentation relating to the purchase of chlorine from All Pure Chemical Company.

This firm has quoted a price of \$340.00 per ton for chlorine delivered to our plant. There is also the typical deposit for containers which is refundable on return.

A second quotation was received from Pennwalt which was \$345.00 per ton. Additionally we had to go to their plant in Portland to pick up the chlorine. The quotation, and delivery, by All Pure Chemical Company eliminates a substantial cost for picking up containers and, equally significant, reduces our potential liability exposure while we transport the chlorine in our truck.

Recommendation - I recommend that the City enter into a contract with All Pure Chemical Company to purchase chlorine at a price of \$340.00 per ton delivered to our wastewater treatment plant. This purchase will reduce our dollar costs, and will also reduce our transportation and liability exposure.

SUBJECT: Purchase Agreement for Chlorine - Wastewater Treatment Plant

The City of Wilsonville has purchased chlorine gas from Penwalt Company for at least the last 5 years. The present cost for chlorine is \$345 per ton, and the City of Wilsonville must pick up the order or be charged a delivery fee, which normally runs \$150. To our knowledge until just recently there has not been much competition in the price of chlorine gas.

All Pure Chemical Company and Kalama Washington has provided me a quote to deliver chlorine gas for a total delivered cost to our Wastewater Treatment Plant of \$340 per ton. The City normally uses about 10 tons per year, and as a cost comparison the City would theoretically save \$1,550 year by purchasing chlorine gas from All Pure Chemical Company. There is also the danger of hauling chlorine gas by City crews in the event of a possible wreck or chlorine leak, although the plant staff are trained in the repair of chlorine tank leaks.

All Pure Chemical Company will return our empty tank to Penwalt and credit us the \$750 normal deposit on the one ton cylinders, therefore removing the burden of returning the empty's to Penwalt.

Recommendation

With the aid of the Finance Department prepare a purchasing agreement with All Pure Chemical Company for the Purchasing of chlorine gas. The agreement shall be reviewed by the City Administrator prior to final Council approval.

All Pure Chemical will also provide the service of picking up and returning any and all Pennwalt ton containers, and apply the deposits toward our containers.

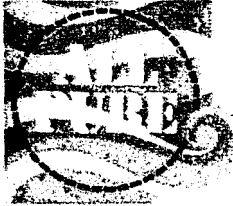
