A RESOLUTION AMENDING RESOLUTION NO. 499 TO SPREAD AND LEVY FINAL PREASSESSMENTS ON PROPERTY IN THE OAKVIEW CONDOMINIUM DEVELOPMENT FOR TOWN CENTER LOOP/PARKWAY AVENUE STREET AND UTILITY IMPROVEMENT DISTRICT NO. 5, HEREINAFTER REFERRED TO AS LID #5.

WHEREAS, the Wilsonville City Council heretofore, by Resolution No. 499, adopted July 15, 1985, spread and levied final preassessments on property benefited for the cost of construction of LID #5; and
