RESOLUTION NO. 535

A RESOLUTION AMENDING RESOLUTION NO. 499 TO SPREAD AND LEVY FINAL PREASSESSMENTS ON PROPERTY IN THE ASH MEADOWS DEVELOPMENT FOR TOWN CENTER LOOP/PARKWAY AVENUE STREET AND UTILITY IMPROVEMENT DISTRICT NO. 5, HEREINAFTER REFERRED TO AS LID #5.

WHEREAS, the Wilsonville City Council heretofore, by Resolution No. 499, adopted July 15, 1985, spread and levied final preassessments on property benefited for the cost of construction of LID #5; and

WHEREAS, a parcel of property commonly known as Tax Lot 2583, Section 13BC, township 3 South, Range 1 West of the Willamette Meridian, Clackamas County, Oregon, and identified in Resolution No. 499 as Preassessment No. 14, is under multiple ownership rather than Ash Meadows, in that each individual condominium is under separate ownership; and

WHEREAS, Stan Ash, as a duly authorized representative of Ash & Associates, Inc., has represented to the City that Ash & Associates, Inc., will pay the assessments of condominuims owned by persons other than Ash & Associates and Ash & Associates desires to bond the assessments for the condominuims it owns, but

needs to have the city break out the assessments for all individual condominuims to accomplish same; and

WHEREAS, to allow proper final preassessment of the property, it is necessary to amend Resolution No. 499 by modifying Preassessment No. 14 to Preassessment No. 14(1) through 14(80).
