## RESOLUTION NO. 575

A RESOLUTION APPROVING THE BID PROCESS; ACCEPTING THE QUALIFIED BID PROCESS; ACCEPTING THE QUALIFIED BID IF FUNDS ARE AVAILABLE; AWARDING OR REJECTING BIDS DEPENDING ON FUND AVAILABILITY; AUTHORIZING THE EXPENDITURE OF FUNDS IF FUNDS ARE AVAILABLE FOR THE BOECKMAN CREEK PUMP STATION PHASE II EXPANSION PROJECT 86-02-006.

WHEREAS, advertisements were printed in the "Daily Journal of Commerce", "Lake Oswego Review" and "Wilsonville Spokesman", as set forth in the requirements established in Oregon Revised Statutes No. 279.025, "Requirements for Advertisement"; and

WHEREAS, sealed bids were received prior to 2:00 o'clock p.m., Pacific Daylight Savings Time, Monday, June 30, 1986, at Wilsonville City Hall, 30000 S. W. Town Center Loop East, Wilsonville, Oregon 97070. Bids were then opened individually and separately and read aloud, after 2:00 o'clock p.m., Pacific Daylight Saving Time, on June 30, 1986, and are listed in the attached EXHIBIT "A"; and

WHEREAS, Westech Engineering, Inc., consulting engineers for the City of Wilsonville, have reviewed all bids received for

The Kregen Company of 1974 - 7th Avenue, West Linn, Oregon 97068, as the bidder to submit the bid with the lowest qualified bid amount, as shown in EXHIBIT "A", attached hereto and incorporated by reference, as if fully set forth herein; and

WHEREAS, staff was advised by the Finance Department that although the project was budgeted, the funds for payment of said construction were not totally available at this time. An additional \$50,000 is necessary to allow award of bid to occur; and

WHEREAS, Westech Engineering, Inc., requested an extension of the award of contract from the qualified low bidder for a period not to exceed August 30, 1986. It is now time to make a final decision either to reject all bids, or award contract to the lowest qualified bidder; and

WHEREAS, if funds are available, in order to assure that the contractor, engineers and other service providers for this project receive prompt payment for work performed, the Construction Management Section shall approve all monthly payments as herein provided.
