RESOLUTION NO. 689

A RESOLUTION ESTABLISHING THE PAYBACK SURCHARGE COST WHICH INCLUDED ENGINEERING DESIGN AND SERVICES DURING CONSTRUCTION, CONSTRUCTION COST INCLUDING, BUT NOT LIMITED TO, LABOR, MATERIALS AND EQUIPMENT, ADMINISTRATIVE, ATTORNEY, PERMIT, PLAN CHECK FEES OR OTHER COSTS INCIDENTAL THERETO; ESTABLISHING THE TEN (10) YEAR PAYBACK PERIOD FOR THE NIKE WATERLINE EXTENSION PROJECT; AND DESIGNATING THE CITY TO COLLECT SUCH SURCHARGE FOR REIMBURSEMENT TO NIKE, INC., AS HEREIN PROPORTIONED.

WHEREAS, on November 7, 1988, at a regularly scheduled City Council meeting, in the Council Chambers at 30000 SW Town Center Loop East, commencing at 7:30 o'clock p.m., the City Council did approve a payback program for the Nike waterline and a map showing the zone of benefited properties and a roll identifying the tax lot owners and their benefited acreage; and

WHEREAS, all costs accountable to the Nike Waterline Extension project have been compiled and are listed in Exhibit No. 1, attached hereto and incorporated by reference herein; and

WHEREAS, Nike, Inc., and Hillman Properties Northwest have agreed to a fixed payback schedule in an agreement letter, dated April 25, 1988, as listed in exhibit No. 3, attached hereto and incorporated by reference herein; and

WHEREAS, a Mylar map 24" X 36" record copy, entitled "Exhibit Map for Nike, Inc., - Water Payback Project" has been placed in the as-built file of the Engineering Department and the payback copy attached hereto and incorporated by reference herein; and

WHEREAS, in compliance with Section 3.116 of the Wilsonville Code, the properties listed in Exhibit No. 2 shall be entered into the lien dockets by the City Recorder for the reimbursement of costs accountable to the construction of the Nike Waterline Extension project, which includes but is not limited to labor, materials, equipment, administrative cost, attorney cost, permit-plan check cost, and other cost incidental to the Nike Waterline Extension project.

NOW, THEREFORE, IT IS HEREBY RESOLVED by the City Council of the City of Wilsonville that:

- 1. Exhibit No. 2 be approved and authorization be given for the City Recorder to enter in the City's lien docket, the properties mentioned, and the sum for each property as prescribed in Exhibit No. 2.
- The payback period shall be designated as being ten
 (10) years from the date of final approval of this resolution.
- 3. All properties mentioned in Exhibit No. 2 shall pay those costs due, prior to connection to the subject waterline, to the City of Wilsonville. The City of Wilsonville shall, upon receiving such surcharge payment, reimburse Nike, Inc.
- 4. Upon receipt of surcharge payment, the City of Wilsonville shall cause all properties and said amount owing as mentioned in Exhibit No. 2, to be removed from the lien docket.

ADOPTED by the Wilsonville City Council at a regular meeting thereof, this 21st day of November, 1988 and filed with the Wilsonville City Recorder this same date.
