## **RESOLUTION NO. 921**

A RESOLUTION AUTHORIZING AN INCREASE IN FEES FOR USERS OF THE CITY OF WILSONVILLE CITY WATER SERVICE AND AMENDING RESOLUTION NO. 841, ARTICLE II, SECTION 1.

WHEREAS, water user fees shall be reviewed annually by the City Council; and WHEREAS, the City Council may increase fees giving due consideration to the increase in the consumers price index (CPI) for the Portland Metropolitan Tri-County area from the month of the last increase to the month preceding the date of the review. The Council may take action not to increase fees in any year it is deemed appropriate to do so; and

WHEREAS, the City Council must give due consideration to the need to maintain rates adequate to repay bonded debt pertaining to water system infrastructure improvements and replacement. It also must sure the system will be able to meet the demands placed on it; and

WHEREAS, the City Council has determined that the water user fees be increased by ten percent (10%) to help accomplish this need.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

1) Water user fee rates listed in Article II, Section 1 of Resolution No. 841 is amended and replaced by the User Fee Schedule below, effective July 1, 1992.
