WHEREAS, it has been represented to the City Council by Attorney Corday in Exhibit A that appellants, through their attorney Richard Allan, consent to the resetting.


NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:
