## **RESOLUTION NO. 1197**

A RESOLUTION OF THE CITY OF WILSONVILLE REPEALING RESOLUTION NO. 1176 AND INITIATING ACTION TO TRANSFER JURISDICTION OF CERTAIN COUNTY ROADS (SW. RIDDER ROAD-COUNTY ROAD NUMBER 558 AND 561) LYING WITHIN THE CITY OF WILSONVILLE TO THE CITY OF WILSONVILLE.

WHEREAS on May 15, 1995 the City Council of the City of Wilsonville adopted Resolution No. 1176 requesting the transfer of jurisdiction of certain county roads lying within the City of Wilsonville to the City of Wilsonville; and

WHEREAS, Resolution No. 1176 adopted by the City Council of the City of Wilsonville on May 15, 1995, contains language which is unacceptable and must be corrected prior to the proper transfer to the City by Washington County; and

WHEREAS, both the City of Wilsonville and Washington County are desirous of the proper transfer of jurisdiction; and

WHEREAS, ORS 373.270 (6) provides a mechanism to transfer the jurisdiction of certain county roads within the City of Wilsonville to the City of Wilsonville; and

WHEREAS, the City of Wilsonville has determined it necessary, expedient and in the best interests of the City of Wilsonville to acquire the jurisdiction over certain county roads, identified as SW. Ridder Road (County Road No. 558 and No. 561), or part thereof to the same extent as it has over the other public streets and alleys of the City of Wilsonville.

NOW, THEREFORE, THE CITY OF WILSONVILLE CITY COUNCIL RESOLVES AS FOLLOWS:

- 1. Resolution No. 1176 adopted by the City of Wilsonville on May 15, 1995 is hereby repealed.
- 2. The City Council of the City of Wilsonville hereby requests that the Commissioners of Washington County, Oregon, transfer jurisdiction of Ridder Road (County Road No. 558 and No. 561) described and depicted in Exhibit "A" and "B" attached hereto and incorporated, to the City of Wilsonville; said transfer to be granted of denied within one year of the date of execution of this Resolution by the City of Wilsonville.
