

RESOLUTION NO. 1347

A RESOLUTION CALLING FOR A ROAD UTILITY FEE FOR STREET MAINTENANCE AND RECONSTRUCTION TO BE VOTED UPON AT THE ELECTION TO BE HELD ON MARCH 11, 1997.

WHEREAS, due to passage of Ballot Measure 47, the City of Wilsonville Budget Committee recommended to the City Council that the Road Utility Fee be referred to the voters at the March election; and

WHEREAS, the purpose of the fee is to provide adequate funding for the purpose of maintaining a safe, functioning city street system measured at an overall annual Pavement Condition Index (PCI) in the 70-75% range.

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

1. A special election is hereby called for the purpose of submitting to the voters of the City of Wilsonville a Road Utility fee to replace the three-year street maintenance serial levy of \$.17 per \$1,000 of assessed valuation outside the City's tax base and which expires June 30, 1997.
2. The road utility fee shall be effective upon passage of the ballot measure.
3. Engineering standards for trip generation and/or vehicle weight classification shall be the basis upon which monthly fees are assessed for the cost of road maintenance and reconstruction. This fee shall be apportioned by the City Council to residential, commercial, industrial, and other types of real property located within the city in proportion to the road usage associated with these properties.
4. The total fees to be collected annually shall not exceed \$500,000 as adjusted by the Consumer Price Index (CPI) for the Portland metropolitan area.
5. Undeveloped properties shall be exempt from the fee because they do not impact the road system.
6. South Metro Area Rapid Transit (SMART) and public schools shall be exempt from the fee because transit and public school bussing have the net effect of reducing vehicles miles traveled.


7. Churches and other places of worship that generate traffic primarily on the weekends shall be exempt from the fee because average weekday traffic is used as a basis for the fee calculation.
8. The City Manager is instructed to prepare the ballot title to be filed with the Elections Officer subject to the review and approval of the City Attorney.
9. The election hereby called shall be held on March 11, 1997, and shall be a mail-in ballot.
10. The City Recorder shall cause to be delivered to the Elections Officer of Clackamas and Washington Counties the Notice of Measure election no later than January 9, 1997, which is the filing deadline for ballot measures for the March 11, 1997, Special Election. The Elections officers shall conduct the election as required by law.
