

RESOLUTION NO. 1355

**A RESOLUTION ACCEPTING TITLE TO CERTAIN SECTIONS OF PARKWAY AVENUE FRONTAGE ROAD NORTH, BOONE'S FERRY FRONTAGE ROAD WEST AND BOECKMAN ROAD OVERCROSSING APPROACHES FROM THE STATE OF OREGON, DEPARTMENT OF TRANSPORTATION, AND TO REJECT TITLE TO CERTAIN OTHER SECTIONS OF SAID ROADS.**

WHEREAS, on January 18, 1984, by its Resolution 614 the Oregon Transportation Commission purported to convey the roads Parkway Avenue Frontage Road North, Boone's Ferry Frontage Road West and Boeckman Road Overcrossing Approaches, as more particularly described in said Resolution, to the City of Wilsonville; and

WHEREAS, the City never accepted title to this property; and

WHEREAS, the state will be using the right-of-way of the northern sections of Parkway Avenue Frontage Road North and Boone's Ferry Frontage Road West for the Stafford Road Interchange Project; and

WHEREAS, the Stafford Road Interchange project has been coordinated with the City; and

WHEREAS, at this time it is the City's interest to accept title to certain sections of these roads and reject those sections needed for the interchange project;

NOW, THEREFORE, THE CITY OF WILSONVILLE RESOLVES AS FOLLOWS:

1. The City Council hereby accepts title to the following described sections of State of Oregon right-of-way:

a. Parkway Avenue Frontage Road North

All the land within the right-of-way boundaries of the Parkway Avenue Frontage Road North, lying easterly of and parallel to the Pacific Highway, State Primary Highway No. 1, as now located from approximately opposite Highway Engineer's Station 461+22.60; thence northerly to approximately opposite Highway Engineer's Station 443+00 outside the access control fence line and lying in Section 11, Township 3 South, Range 1 West, Willamette Meridian; Clackamas County, Oregon.

b. Boone's Ferry /Frontage Road West


All the land within the right-of-way boundaries of the Boones Ferry Frontage West, lying westerly of and parallel to the Pacific Highway, State Primary Highway No. 1, as now located from approximately opposite Highway Engineer's Station 528+43.70; thence northerly to approximately opposite Highway Engineer's Station 441+50, outside the access control fence line and lying in Section 11 and 14, Township 3 South, Range 1 West, Willamette Meridian; Clackamas County, Oregon.

c. Approaches to Boeckman Road Overcrossing


All the land within the right-of-way boundaries of Boeckman Road that are the approaches to the Boeckman Road Overcrossing as part of the Pacific Highway, and lying in Section 11 and 14, Township 3 South, Range 1 West, Willamette Meridian, Clackamas County, Oregon.

2. The City Council hereby rejects and conveys to the State of Oregon, by and through its Department of Transportation, claim of title or title to those sections of Parkway Avenue Frontage Road and, Boone's Ferry Frontage Road West northerly of the aforementioned Engineer's station.
