- ★ Choosing routes that provide space to walk and have the least amount of traffic and lowest speeds
- ★ Looking for traffic at all driveways and intersections
- ★ Wearing a properly fitted bicycle helmet
- ★ Using hand signals for crossing an intersection
- ★ Personal safety and active transportation and public spaces

PLANNING ASSISTANCE: PROJECT IDENTIFICATION PROGRAM (PIP)

Approximately every two years, ODOT opens grant applications for cities, tribes, road authorities, or school districts to apply for consultant planning assistance to identify street safety needs near one school or a cluster of schools feeding into the same middle or high school. GRANT FUNDING

Competitive Construction Grant applications open approximately every two years, ODOT opens grant applications for cities, tribes, counties, or road authorities to fund street safety in the right of way within a one-mile radius of schools, in order to help students walk+roll to school safety. RAPID RESPONSE GRANTS

Rapid Response Grant applications are always open to tribes, cities, counties, or road authorities to provide an immediate infrastructure change in response to a fatality or urgent concern related to students walking and rolling to school.
